Waiver of Liability & Indemnity Agreement:

I understand that in consideration and exchange for, and as a condition of my participation in any and all Bases Loaded Tournaments, Inc. (hereinafter, "Bases Loaded Tournaments") tournament(s), game(s) showcase(s), practice(s), and/or related activit(y)/(ies) (collectively, "Event(s)"), I knowingly and freely release and indemnify Bases Loaded Tournaments and all Bases Loaded Tournaments owners, employees, officers, directors, volunteers, sponsors, advertisers, parent organizations, subsidiaries, affiliates, dbas, agents, insurers, facility owners of the premises used, promoters, vendors, service providers, and related independent contractors from all responsibility to me, my parents and/or guardians, my estate, heirs, executors, personal representatives, insurers, successors and assigns for anything that occurs during the Event(s). It is my intention that this release and indemnification extend to my participation in the Event(s) and to my use of any and all Event(s)-related facilities, equipment, supplies, products, and/or connected services, including but not limited to, my use of the facilities and/or services during the Event(s) and any practice or warm-up prior to the Event(s), as well as my use of the facilities and/or services following the Event(s). I acknowledge that Bases Loaded Tournaments is a privately held organization and has the right to refuse or discontinue the participation of any customer or participant in any Events. In the event I institute any legal proceeding against Bases Loaded Tournaments for any reason, Bases Loaded Tournaments further reserves the right to suspend or exclude me from participation in any Events.

Waiver and Assumption of Risk:

I acknowledge that by signing this document, I am assuming risks, and agreeing to indemnify, not to sue, and release from liability, the organizer of this Event, Bases Loaded Tournaments, and all Bases Loaded Tournaments owners, employees, officers, directors, volunteers, sponsors, advertisers, parent organizations, subsidiaries, affiliates, dbas, agents, insurers, facility owners of the premises used, promoters, vendors, service providers, and related independent contractors (collectively, "Releasees"), and that I am giving up substantial legal rights. This release is a contract with legal and binding consequences, and it applies to all Events, and/or related activities associated with such Event(s), regardless of whether or not specifically listed above. I have read this document carefully before signing, and I understand what it means and what I am agreeing to by signing.

I understand and acknowledge that baseball and/or the Event(s) involve inherent risks and dangers - baseball is an inherently dangerous activity, and I fully realize the dangers of participating in this/these Event(s). I also understand that by participating in the Event(s) and pre-/post-Event activities, I am exposing myself to the possibility of serious injury, COVID-19, sickness and disease (including communicable diseases, virus or bacteria), trauma, pain and suffering, emotional and mental stress or injury, permanent disability, disfigurement, or even death to my person, as well as loss of or damage to my personal property. These possible injuries, death, and/or damages may result from my own actions or inactions, as well as the actions or inactions of others, the rules of play, and the condition of the facilities and/or equipment. Further, there may be other risks not known to me and not reasonably foreseeable at this time. I have considered the nature

and extent of the risks involved, and I knowingly and voluntarily accept these stated risks, known and unknown, and fully assume the risks associated with such participation. I additionally consent to treatment in the event of an emergency or other incident in which, in the reasonable judgment of the on-site personnel, each of whom are deemed Releasees hereunder, I require medical or other care or attention.

Indemnity and Release:

I hereby for myself, my estate, my parents and/or guardians, heirs, executors, personal representatives, insurers, successors, and assigns, irrevocably waive, release, discharge, hold harmless, and promise to indemnify and covenant not to sue the Releasees, and each of their officers, agents, officials, employees, successors, and/or assigns from any and every claim or right of action of any kind or nature, including claims arising from the Releasees' own negligence, which arises out of or results from my participation in this/these Event(s). I also agree to indemnify and hold harmless Bases Loaded Tournaments from all such claims or rights of action, including costs, monetary loss or expense in any way related to or arising out of those claims or rights of action, including attorney fees.

It is my intention that this waiver of liability agreement, and the indemnity and hold harmless provision described above, shall cover any claim or demand for any type of injury or illness to or death or disability of any person, or any damage to or loss or destruction of any property, or any claim or demand of any kind or nature whatsoever including but not limited to, injury to or death of any person or damage to, loss of, or destruction of any property, any damage to or loss of my reputation, business, or business relationships, and damage to or loss of emotional and mental health and well-being, which may arise out of or relate to any acts or omissions of Bases Loaded Tournaments, its officers, agents, officials, employees, successors, and/or assigns, even if said act or omission would be considered negligent under applicable circumstances.

By signing this release and waiver of liability agreement, I do not release anyone from any damage I suffer from intentional acts designed to harm either me or my property. However, I do knowingly release Bases Loaded Tournaments from any liability that might be imposed on Bases Loaded Tournaments by law or equity for such acts of their officers, directors, agents, officials, employees, successors and/or assigns that are beyond their scope of employment or authority, and/or have not been directed, adopted or ratified by an officer or director of Bases Loaded Tournaments.

I declare that I have read this waiver of liability agreement and fully understand that no officer, agent, official, employee, successor and/or assign of Bases Loaded Tournaments is authorized to vary any term or provision of this waiver of liability agreement. I expressly agree not to rely on any such variance or representation if any is made. I further represent that the participant listed on the related entry form possesses the standard of competence necessary and is physically fit to compete in this/these Event(s). I further represent that the equipment and products to be provided by the participant and utilized by the participant are suitable for use and participation in this/these Event(s) and have not been and will not be altered or modified changed, or misrepresented for any impermissible or illegal purpose, use, or reason, including any undue competitive advantage, and I bear full risk and responsibility for all results, conditions, and consequences directly or indirectly resulting from the intended and reasonably foreseeable use or handling of and exposure to such equipment and products by me or other participants.

I certify that I shall comply with all Bases Loaded Tournaments rules, and I specifically agree that Bases Loaded Tournaments' interpretation of rules, decisions enforcing rules, interpretation of penalties in connection with enforcement of rules, timing of Events and decisions as to winners and rankings shall be final and not subject to protest of any kind. No decision of Bases Loaded Tournaments with respect to game, showcase, or personal player metrics results may be challenged by litigation or otherwise. I understand that any statements made by me or anyone acting on my behalf that challenge the integrity of Bases Loaded Tournaments' decisions with respect to game, showcase, and/or personal player metrics results will cause irreparable harm to Bases Loaded Tournaments' business reputation and subject me to damages under applicable law. I also certify that

I have read and will comply with all supplemental or amended rules specifically published for the Event(s) in any Event bulletins and/or on the Bases Loaded Tournaments website.

There is always the possibility that weather conditions or other acts of God could cause Bases Loaded Tournaments to postpone or cancel the Event(s). Bases Loaded Tournaments retains the right to delay and/or cancel the Event(s) in its sole discretion.

Grant of Rights and Release:

I understand that the Event(s) may be recorded, including in photographs, video recordings, audiotapes, digital images, other media, and the like taken, made or otherwise recorded ("Recordings"), and I agree that Bases Loaded Tournaments may use my name, image, likeness, voice, athletic performance, biographical information and/or appearance (in any form without regard to distortions of character, form, or color, or any other alteration) in such Recordings, without any additional consideration to me or to any third party. I hereby grant to Bases Loaded Tournaments a Non-Exclusive irrevocable right and license to use my name, image, likeness, voice, athletic performance, biographical information and/or appearance as such may be embodied in any Recordings taken or made by or on behalf of Bases Loaded Tournaments or its affiliates, at this Event or any future Bases Loaded Tournaments Events in which I participate in any and all present and future media in perpetuity, on or in connection with (i) my participation in the Events (ii) the creation, distribution, marketing, advertising, sponsorship, promotion, broadcast, programming, social media content, and publication, of the Events and Bases Loaded Tournaments. I hereby assign all rights, title and interest, including copyright in and to any and all such Recordings and hereby irrevocably agree that Bases Loaded Tournaments has full and complete ownership of all Recordings and any materials created in connection therewith. I acknowledge that I will not receive any compensation for the use of such name, image, voice, athletic performance, biographical information and/or appearance. I hereby release and discharge Bases Loaded Tournaments, and its agents, representatives and assignees from any and all claims and demands arising out of or in connection with the use of my name, image, voice, athletic performance, biographical information and/or appearance, including any and all claims for compensation, invasion of privacy, right of publicity, misappropriation or misuse of image. Bases Loaded Tournaments and all partners, sponsors and/or affiliates agree no athlete endorsements will be published and no collected memorabilia, trading cards, collectibles, products will be sold without a direct written agreement between Bases Loaded Tournaments and/or all partners/sponsors/affiliates and the applicable player and/or his parent or legal guardian where applicable. This release shall be binding upon me, my heirs, legal representatives, and assigns.

This agreement is being made and entered into under the laws of the state of Florida and shall be governed and interpreted in accordance with the laws of said state. This agreement embodies the entire agreement of the parties (participant and photographer). No modification of this agreement shall be of any effect unless it is made in writing and signed by all of the parties to the agreement.
